

DEALER APPLICATION CHECKLIST (DAC) – CAR SHARE FLEET

Please Note: Every checkbox must be checked in order for the Application to be approved.

In order to meet CleanBC Go Electric Passenger Vehicle Rebate program targets, the BC Ministry of Energy, Mines and Low Carbon Innovation (the "Ministry") can modify any component of the program at any time without prior notice. This program modification can include but not limited to, the addition of new vehicle types, vehicle and fuelling investment levels, and any program aspect that the Ministry wishes to change. The program is funded by BC Hydro ("BCH").

- Dealer is a Member in good-standing with the New Car Dealers Association of BC (NCDCA).
- Upload this document with the [Letter of Received Rebate](#), and the Bill of Sale/Lease Agreement (minimum 36-month lease) indicating the vehicle is Eligible and New.
- The purchaser/lessee of the vehicles is a car share business, non-profit, or public entity that is licensed to operate in BC and is based in BC or has a BC-based affiliate (including municipal and regional governments and First Nations, but excluding provincial, crown, and federal government agencies). A Valid BC Incorporation Number needs to be inputted on the online form and/or a copy of a BC Registry Services Company Summary needs to be attached.
- No modifications have been made to the vehicle's emissions control systems, hardware, software calibrations or hybrid system.
- The applicant is an [eligible car share fleet operator](#) approved by the Ministry.
- A line item must be on the Bill of Sale/Lease Agreement that clearly lists the rebate as "CleanBC Go Electric", with the rebate amount explicitly shown.

MANDATORY CUSTOMER DECLARATIONS:

- I give permission to be contacted by email, or other electronic means for the purposes of participating in a survey regarding my experience with the CleanBC Go Electric Passenger Vehicle Rebate program and for informing future programs and policies related to electric vehicles. I have been advised that I may withdraw my consent at any time by providing the required notice by sending an email to: ZEVPrograms@gov.bc.ca
- I acknowledge that I am required to keep this vehicle plated, registered and insured in BC under my own name for a minimum of 12 months (the "Requirements"). If I fail to do so, I will be required to return the full CleanBC Go Electric rebate amount, and I acknowledge that I will be immediately liable to dealer and/or Ministry/BCH, without setoff or counterclaim, for the whole of this rebate amount.
- I give permission to the dealer and the Ministry/BCH to be contacted by email, or electronic messages in order to confirm I am in compliance with the Requirements. I have been advised that I may withdraw my consent at any time by providing the required notice. If I do so, I will be required to return the full CleanBC Go Electric Passenger Vehicle rebate amount, and I acknowledge that I will be immediately liable to dealer and/or Ministry/BCH, without setoff or counterclaim, for the whole of this rebate amount.
- I give permission to the dealer and the Ministry/BCH to contact ICBC for the purpose of confirming that I am in compliance with the Requirements, and I give ICBC such authority as is necessary for them to release the information reasonably necessary to make such confirmation.
- I acknowledge that **effective December 1, 2020, car share fleet applicants can receive up to fifty (50) rebates during the lifetime of the Program.** If I exceed the limit, I will be required to return the full CleanBC Go Electric Passenger Vehicle rebate amount, and I acknowledge that I will be immediately liable to dealer and/or the Ministry/BCH, without setoff or counterclaim, for the whole of this rebate amount.
